INFORMATION AND INSTRUCTIONS TO CANDIDATES

1) PROGRAMMES OF STUDY

Five year Integrated Programmes leading to (1) M.Sc. (Computer Science) (2) M.Sc. (Information Technology) and (3) M.Sc. (Electronic Media) are offered at the University Departments of Anna University (College of Engineering Guindy Campus), Chennai - 600 025 under Self-Supporting Scheme.

2) DURATION OF THE PROGRAMME

Five Academic years comprising of Ten semesters.

3) ELIGIBILITY FOR ADMISSION

a) M.Sc. (Computer Science) / M.Sc. (Information Technology)

A pass in HSC (Academic), with Mathematics, Physics and Chemistry as three of the four subjects of study prescribed under Part - III or its equivalent with a minimum average mark of 45% for OC, 40% for BC/BCM/ MBC & DNC /SC/SCA/ST category. The average mark refers to the marks obtained in Mathematics, Physics and Chemistry put together.

b) M.Sc. Electronic Media

Candidates should have passed the Higher Secondary Examination of 10+2 Curriculum of any group under Part - III or any other Examination of any University (or) authority approved by Anna University, as equivalent there to.

4) REGISTRATION OF APPLICATION

Candidates desirous of applying for (1) M.Sc. Computer Science / Information Technology (2) M.Sc. (Electronic Media) shall register applications separately for (1) & (2).

5) NATIVITY CRITERIA

Candidates should be Indian Nationals.

Candidates should satisfy one of the following Nativity criteria:

i) Tamil Nadu candidates who have passed VIII, IX, X, XI and XII Std. from schools situated in Tamil Nadu are eligible to apply. They need not produce Nativity Certificate for verification.

- ii) Tamil Nadu Native candidates who have passed any of the VIII, IX, X, XI and XII Std. or their equivalent examination from schools situated outside Tamil Nadu can also apply. They should submit Nativity Certificate only as digitally signed e-Certificate.
- iii) Children of Central Government Employees may also apply for admission, irrespective of their native, provided their parents or guardians (only if both parents are not alive) have been serving in Tamil Nadu continuously for the past FIVE YEARS at the time of submission of application. This should be supported by producing a certificate from the employer of the parent or guardian, to that effect.
- iv) Children of employees in Public Sector or Government recognized Institutions who at the time of submission of application for admission employed in Tamil Nadu continuously for the past five years may also apply irrespective of their domicile. A certificate from the employer stating that the person is a Permanent Employee of the Firm or Institution concerned with evidence like Income Tax return, PF Slips, etc. and is working in Tamil Nadu continuously for the past FIVE YEARS has to be produced.
- v) Sons and daughters of All India service Tamil Nadu cadre officers are eligible to apply. A Self declaration from the parent in this regard is to be produced.
- vi) Other State candidates who have studied VIII, IX, X, XI and XII Std. in Tamil Nadu are eligible to apply. They need not produce Nativity Certificate.

Note:

- 1. Applications without proper Nativity Certificate for Category (ii) without proper employer certificate for categories (iii) and (iv) and without self-declaration from the parent for category (v) will not be considered.
- 2. Category (vi) need not produce employer certificate / nativity certificate.
- 3. Categories from (iii) to (vi) will be considered under Open Competition.

Srilankan Tamil Refugee:

As per G.O. (St) No. 172 Higher Education (J2) Dept. dated: 29.06.2010 candidates who are Srilankan Tamil Refugee studied in Tamil Nadu will be considered under open competition. They have to produce the following certificates.

- (i) Identification certificate from the Head Quarters Tahsildar.
- (ii) Those who have not registered in the refugee camp should produce original passport, visa and letter registered with Police Station.

6) MERIT LIST

(A) M.Sc. (COMPUTER SCIENCE) / M.Sc. (INFORMATION TECHNOLOGY)

The merit list will be prepared based on the aggregate marks obtained for 300 (Mathematics-100; Physics-100; Chemistry-100). Admission will be based on Tamil Nadu Communal Reservation Policy.

In cases where more than one candidate have got the same marks in the common merit list, the inter-se-merit among such candidates shall be determined in the order of priority as specified below. (i). percentage of marks in Mathematics (ii). percentage of marks in Physics (iii). percentage of marks in the optional subject (iv). percentage of total marks in XII Standard Examination (v). date of birth (elder will be given preference) and (vi). Random number Assigned (higher value will be given preference)

(B) M.Sc. (ELECTRONIC MEDIA)

A merit list will be prepared based on the percentage of marks obtained in the subjects under Part III (Except Part I - Language and Part II - English). Admission will be based on Tamil Nadu Communal Reservation Policy.

In cases where more than one student have got the same marks in the common merit list, the inter-se-merit among such students shall be determined in the order of priority as specified below: (i). Percentage of Total marks in the qualifying Examination (ii). Date of Birth (iii). Random

number assigned.

7) **COMMUNAL RESERVATION:**

Allotment of seats will be through Online Counseling following the rule of reservation of Government of Tamil Nadu. Reservation shall be made under categories namely OC, BC, BCM, MBC & DNC, SC, SCA and ST.

Tamil Nadu Native candidates alone will be considered for communal reservation and the list of communities eligible for communal reservation is given in Annexure – I.

Candidates seeking admission against BC / BCM / MBC & DNC / SC / SCA / ST categories should have obtained the community certificate (Card format or digitally signed e-Certificate) from a competent authority specified in **Table -I**.

However, the candidates who belong to BC, MBC and DNC communities in a particular district, migrated to other places in Tamil Nadu and obtained community certificates from competent authorities in the migrated district on or after 28.10.2009, will be considered. (as per G.O. (St) No. 95 BC, MBC & Minorities Welfare Department, dated: 28.10.2009).
c)	Candidates who failed to upload a self-attested photocopy of the permanent community card or digitally signed e-certificate at the time of registration of the application will be treated under Open Competition (OC) category. In the event of such a decision, the eligibility conditions and rules prescribed for OC category will be applicable for such candidates.

8) DIFFERENTLY ABLED PERSONS CATEGORY:

Only Tamil Nadu Native Candidates are eligible for reservation under this category. **Five percent of seats are reserved for Persons with benchmark disabilities.**

Note:

Candidates seeking admission against reservation set apart for Visually Impaired, Hearing impaired (Deaf), orthopedically Differently Abled Persons, Autism, Multiple disabilities should produce the certificate from the **Medical Board (minimum 3 doctors) of the District** concerned certifying the nature and **extent of disability in percentage** and with regard to his/her suitability for admission to Engineering Colleges specifically mentioned under 5.2 and in the format (Certificate No. I/II/III/IV/V). Certificates obtained from an **individual Doctor** will not be considered. **Further, a separate medical Board for each category will examine the candidates with reference to their certificates.**

8.1 ELIGIBILITY CRITERIA FOR VARIOUS DISABILITIES

A. Norms for Visual Impairment

Candidates with low vision of 40% and above are considered as disabled, and hence eligible for claiming Engineering Admission against Differently Abled Persons category (Certificate No. I).

- **1.** "**Blindness**" means a condition where a person has any of the following conditions, after best correction—
 - (i) total absence of sight; or
 - (ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
 - (ii) limitation of the field of vision subtending an angle of less than 10 degree.
- 2. "Low-vision" means a condition where a person has any of the following conditions, namely:—
 - (i) Visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
 - (ii) Limitation of the field of vision subtending an angle of less than 40 degree upto 10 degree. Person with impairment of vision of less than 6/18 to 6/60 with best correction in the better eye or impairment of field in any one of the following categories:
 - (a) Reduction of fields less than 50 degrees, (b) Heminaopia with macular involvement, and (c) Attitudinal defectinvolving lower fields categories of Visual Disability all with correction.

B. Norms for Hearing Impairment

Candidates with hearing ability of 40 db and above only in the better ear with speech discrimination score of 50 % and above are considered disabled and hence eligible for claiming Engineering Admissions against Differently Abled Persons category (Certificate No. II).

- 1. "Deaf" means persons having 70DB hearing loss in speech frequencies in both ears.
- **2. "Hard of hearing"** means person having 60DB to 70DB hearing loss in speech frequencies in both ears.

c. Norms for Locomotor Disability

Candidates with permanent physical impairment of 40 % and above are considered as disabled. The candidates with Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy of the following types are eligible for claiming Engineering Admission against Differently Abled Persons category (Certificate No. III).

- 1. Locomotor disability (a person's inability to executed instinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both).
 - (i) Independent in ambulance with <u>or</u> without calipers but without walking aids. (ii) Good Standing Balance without calipers but without any support. (iii)Hand Function with normal limit without any aid. (iv)Good control over bladder & bowel. (v) Disease must be non-progressive.
- 2. "Leprosy cured person" means a person who has been cured of leprosy but is suffering from—
 - (i) Loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
 - (ii) Manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
 - (iii) Extreme physical deformity as well as advanced age which prevents him/her from under taking any gainful occupation, and the expression "leprosy cured" shall be construed accordingly;
- **3.** "Cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;

^{*} ONE EYED persons with normal vision are not considered as disabled.

- **4. "Dwarfism"** means a medical or genetic condition resulting in an adult height of 4 feet 10inches (147 centimeters) or less;
- **5.** "Muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human

body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterised by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;

6. "Acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

D. Norms for Autism, Intellectual Disability, Specific Learning Disability and Mental Illness

Candidates with permanent physical impairment of 40% and above are considered as disabled. The candidates with Autism, Intellectual Disability, Specific Learning Disability and Mental Illness of the following types are eligible for claiming Engineering Admission against Differently Abled Persons category (Certificate No.IV).

- **1.** "Speech and language disability" means a permanent disability arising out of conditions such as laryngectomyoraphasia affecting one or more components of speech and language due to organic or neurological causes.
- **2. Intellectual disability,** a condition characterized by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including—
 - (i) "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and development alaphasia;
 - (ii) "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereo typical rituals or behaviours.
- **3. Mental behaviour**—"mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by sub-normality of intelligence.

4. Disability caused due to—

- (i) chronic neurological conditions, such as—
 - (a) "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelization and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
 - (b) "Parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the

neuro transmitter dopamine.

- (ii) Blood disorder—
 - (c) "hemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterized by loss or impairment of the normal clotting ability of blood so that a minor would may result infatal bleeding;
 - (d) "Thalassemia" means a group of inherited disorders characterized by reduced or absent amounts of hemoglobin.
 - (e) "Sickle cell disease" means a hemolytic disorder characterized by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of hemoglobin.

E. Norms for Multiple Disabilities

Candidates with multiple disabilities with permanent physical impairment of 40 % and above are considered as disabled and they are eligible for claiming Engineering Admission against Differently Abled Persons category (Certificate No. V).

Multiple Disabilities (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.

9) POST MATRIC SCHOLARSHIP

In the G.O. (st) No. 6 Adi Dravidar and Tribal Welfare (AD3) Department dated 09.01.2012, G.O. (st) No. 92 Adi Dravidar and Tribal Welfare (AD3) Department dated 11.09.2012 and G.O. (st) No. 16 Adi Dravidar and Tribal Welfare (AD3) Department dated 24.02.2014, the Government have ordered to grant Post Matric Scholarship to SC/SCA/ST candidates and SC/SCA converted Christians, whose parental annual income is less than Rs. 2,50,000/- from all the sources shall only be eligible. The eligible candidates have to submit income certificate obtained from appropriate authorities and get the Post Matric Scholarship from the colleges where they get admitted.

10) APPLICATION / REGISTRATION FEE

Only Online Payment - ₹1000/- (+18% GST) for OC / BC /BCM / MBC & DNC and ₹ 500/- (+18% GST) for SC / SCA /ST candidates belonging to Tamil Nadu.

11) **COUNSELING:**

At the time of Choice filling / Counseling, the candidates have to pay Rs. 5,000/- for OC / BC/BCM / MBC & DNC and Rs. 1,000/- for SC / SCA / ST candidates belonging to Tamil Nadu as Initial deposit which will be adjusted against the tuition fee payable at the time of admission. The candidates have to pay a non – refundable counseling Fee: Rs.300/- (+18% GST) for OC / BC/BCM / MBC & DNC and Rs. 150/- (+18% GST) for SC / SCA / ST candidates belonging to Tamil Nadu.

An applicant who declines after the publication of Tentative Allotment OR an applicant who is not allotted a Branch during Provisional Allotment shall be eligible for 100% Refund of the Initial Deposit. After provisional allotment, an applicant who does not join the branch allotted shall be

eligible for 80% of Refund of the initial deposit. The candidates eligible for refund should apply through the Web Portal (cfa.annauniv.edu/cfa) within six months from the date of counseling. The application for refund submitted beyond six months will not be considered.
